Note:

Cereals was included in our Responsible Sourcing program in 2017. We are working to map our supply chain, starting with wheat and corn and focusing on the countries where we buy the biggest volumes. As of June 2019, we have traced 36% of the volume of cereals (wheat and corn) that we source back to at least the country of origin. We will continue to map these supply chains further. This disclosure covers cereals that we buy for our Food, Confectionary, Dairy, Breakfast Cereals and Pet Food businesses. In some cases, we buy directly from farmers or elevators. In these cases, we don't dislose the names of individuals.

As with any traceability efforts, this is a snapshot that reflects our supply chain-mapping efforts, which is a mix of selfdeclaration and paper based verification, and should not be taken as fully exhaustive nor fully accurate as supply chain flows evolve on a daily basis.
